It is required by The California T-Shirt Company, LLC, DBA Black Mamba Skate Park / Releasee that this Hold Harmless Release be completed by each participant over 18 or participant's parent or legal guardian. The mandatory understanding concerning participation is listed as follows:

**PART ONE:**

1 If participant is under 18 you give your child, identified on the top of this form, permission to participate at Black Mamba Skate Park and to enter for any purpose any restricted area wherein admittance to the general public is prohibited. .

2. I/WE HEARBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Black Mamba Skate Park, participants, officials, skate park employees, sponsors, advertisers, lessees of the premises used to conduct the event and such them their officers, agents and employees, all for the purposes herein referred to as "Releasee," from all liability to the undersigned, my/our personal representatives, assigns, executors, heirs, including but not limited to death of the participant or damage to property, caused or alleged to be caused in whole or in part by the negligence of the "Releasee" or otherwise.

3. You state that you are aware of all the inherent dangers and risk involved in skate park/roller rink participation including but not limited to: bodily injury, sprains, fractures, dislocations, lacerations, concussions, skin disease, eye, head, neck or back injuries, or death. There may be other risks not known to us or are not reasonably foreseeable at this time.

4. You understand that Black Mamba Skate Park does not provide any Accident or Medical Insurance and that you are required to provide this for your child. You agree that you are financially responsible for all medical expenses whatsoever.

5. You understand that the terms of this agreement are legally binding and certify that you are signing this agreement of your own free will after carefully reading it.

**PART TWO: Medical Authorization**

In the event of serious illness or injury, I authorize Black Mamba Skate Park to call an ambulance to transport (as deemed necessary) myself or my child to a hospital emergency facility for treatment. All reasonable attempts to contact a parent or guardian will be made. I accept responsibility for all costs involved in the transport and treatment.

**PART THREE: Facility Rules and Regulations**

1. Helmets must be worn at all times by all participants in the skateboard area or using big wheels. Use of other protective gear is recommended. (helmet/wrist/elbow/knee pads) Parent(s) and or legal guardian(s) will instruct the minor participant that prior to participating he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe the participant should immediately advise the staff of such condition and refuse to participate.
2. Children ages 6-8 may only skateboard in the designated area for ages 6-12 unless accompanied by a certified instructor. We strongly suggest that children age 6-12 have parental supervision at all times. You must be at least 3 years to use big wheels.
3. All protective gear and equipment must be designed for skateboard/in-line skating/ roller skating and be in good condition. Black Mamba Skate Park staff reserves the right to refuse to allow anyone to skate if their protective gear and equipment is not adequate.
4. All users must get a SESSION PASS at the sign in desk prior to entering the skate area.
5. Prohibited activity within the skate park includes motorized equipment, ripstiks, alcoholic beverages, tobacco products, illegal drugs, pets, graffiti, and tagging.
6. Participants must wear clothing appropriate to activity including shirts and closed toe shoes.
7. No obstacles are to be brought in to the skate park/roller rink.
8. All users agree to act in an orderly, safe and considerate manner while in the skate park. No "snaking." Everyone is to wait their turn. Any unsafe behavior will result in immediate expulsion and possible loss of skate park privileges
9. Users are to immediately report any safety concerns or injuries, whether major or minor in nature to park staff. In the case of a serious injury, do not move the injured person and all activity shall cease immediately.
10. Violation of rules will result in loss of skate park privileges.
